(f) Bids received without EMD will be rejected.



7. Submission of tender will imply the acceptance by the vendor of the terms and conditions given in this tender document.
8. **Performance Bank Guarantee.** The Vendor will be required to furnish an unconditional Bank Guarantee of an amount equivalent to 5% of contract value and valid for **WARRANTY** period + **THREE** months (invocation period) from the date of acceptance. The performance guarantee to be submitted within ONE month after acceptance of goods and before release of full and final payment of the Contract.
9. **Payment Terms:** The payment to the contractor will be made only after completion of work and acceptance by board of officers. Final payment will be released after the date of completion on the submission of 5% of the total amount as security deposit and affidavit for the defect liability.
